Production system issues have apparently been fixed. Once Working Poor table is finished, Target Group Profiles will be started.

TGPs still on the priority list:

- HH TGP of multi-generational households

- HH TGP of households in housing that are unsuitable
- HH TGP of households in subsidized housing
- HH TGP of households in need of major repairs
- TGP of the population living in households spending 30%+ or 50%+ on housing
- TGP of persons in owner/renter households
- TGP by mode of commuting to work, using a compatible universe to what will be used in the 2021 Census

At standard and custom geographies

ACTION: Schedule for delivery of these tables? Impact on 2021 production? PRIORITIZE 2021

Data requests coming out of the 2022 CDP Leads' Meeting

- Gender (5) and Gender (7) at the CSD level
- Data on people with disabilities
- Tableau Server to be able to imbed dashboards into website
- Health data (vital statistics, COVID hospitalizations, access to services, mental health, hospital beds, other administrative health data)
- Data to assess impacts of climate change
- Walk Score data
- CCHS at submunicipal level (aggregating several years of data)
- Air quality data

Longitudinal Administrative Databank tables

We are looking into acquiring data from the Longitudinal Administrative Databank (LAD). **Table suggestions are requested.**

Ontario Ministry of Transportation (MTO) 2021 Census order

The MTO and a group of municipalities will be requesting about 14 tables from the 2021 Census using both Place of Residence and Place of Work geographies. Numerous CDP members are participating and the idea of joining this order was put forward. We would see if MTO is interested in expanding the scope to include all of Canada and try to come up with a cost-sharing model that is mutually beneficial.

Besides saving money on tables that (hopefully) have wide appeal, we would be piggybacking on significant production time that would otherwise be in competition with the CDP's requests. StatCan has described the MTO request as "the other big production project" that's in their queue.

All this has still to be presented to MTO, but it would be good to get sign off from the DPAWG, *particularly from non-Ontario members*. A preliminary list of table titles is provided below and I've attached a preliminary set of specifications. Feel free to share your thoughts/concerns regarding this initiative directly to me via email or during our discussion at the next meeting.

2021 Census custom tables – priority setting exercise

TGP requests have been submitted to STC.

100% sample data – explain to users the difference in the counts
2021 Census Profile - # people in collective dwellings – get matching data from public profile
#occupied private dwellings / # occupied collective dwellings

Total population counts included in the TGPs to be able to produce proportions/prevalence

TGP lists were prioritized using Google documents.

Acquiring data on vacant buildings

dwelling counts grouped as follows:

- Occupied private
- Occupied collective
- Private 2A occupied by foreign residents or temporarily present person (is there a difference between #5 and #11? #5 specifies "private")
- Collective occupied by foreign residents or temporarily present person
- Unoccupied private
- Unoccupied collective
