NPI: using mortgage data as model for lack of good housing data  
TO experienced some onerous restrictions, even on aggregated data

**ACTION:** cost estimate – details on restrictions

**ACTION:** MORE DETAIL in catalogue on restrictive data license

#### 2016 Census tables

TGPs still on the priority list:

- HH TGP of multi-generational households
- HH TGP of households in housing that are unsuitable
- HH TGP of households in subsidized housing
- HH TGP of households in need of major repairs
  
- TGP of the population living in households spending 30%+ or 50%+ on housing
- TGP of persons in owner/renter households
- TGP by mode of commuting to work, using a compatible universe to what will be used in the 2021 Census

At standard and custom geographies

- 2016 Census tables with re-based MBM

There is still interest from the working group in acquiring 2016 data. A need for 2016 Census tables with a re-based MBM is required to have a consistent time series on poverty.

Census production has been slow recently, following a switch to a new production system (featuring down time, bug removal and training) and staffing issues, but in our last meeting with the Central Region Assistant Director and her team we were assured that they were working hard to get enough staff to accommodate our many requests.

## 2021 Census custom tables – priority setting exercise

There are concerns that the COVID income supports are skewing indicators upon which municipal policies and programs will be based.

Peel: income supports skewing income/core housing need data

Is there a way to tease out the effect that the income supports are having?

Toronto: seconds this comment; a table that crosses these variables would be useful...

- Total Income vs Sources of Income vs Low-income lines

Housing table: CHN, affordability – skewed by income supports – cross-tabulate with Sources of income

Is there a way to remove COVID-related income supports from individual incomes before aggregating?  
Have income with and without COVID-related income supports?

REMOVING COVID-RELATED SUPPORTS FROM INCOME DATA WOULD CREATE ITS OWN SET OF ANALYSIS PROBLEMS. ANOTHER OPTION WOULD BE TO USE **2019 INCOME DATA** FOR THESE INDICATORS (LOW INCOME, CORE HOUSING NEED, AFFORDABILITY...).

**ACTION:** ask STC what are they doing to try to account for this “blip” in incomes – use 2019? 2021 may be preferable when available. Ask if/when 2019 or 2021 could be available for 2021 Census table production.

**ACTION:** affordability reporting for Indigenous households? Why not reported? No reporting yet on Indigenous households?

Some suggestions for semi-custom tables were made. See Google Sheet.

**ACTION: TGPs and HH-TGP are priority**

New 2016 TGPs that have not yet been produced should also be included in the 2021 Census order. For example, TGP (individuals) by tenure.

SIMCOE: Has anyone explored households spending 100% of their income on housing? (2% of HHs in Simcoe)

Calgary : has had some interest in this
