Schedule B, 2020-2021

This Schedule B lists data products that the CCSD Community Data Program intends to acquire during the 2020-2021 program year. (Program years run from April 1 to March 31.)

Schedule B contains a list of data products—including both data tables and analytical tools—as well as the names of data providers, and the data delivery schedule. These are reflected in the tables on pages 2-6.

Schedule B is updated regularly

This document is amended regularly, subject to the availability and cost of data. Priorities for data product acquisition are identified with the Data Access and Purchase Working Group with input from Leads and are approved by the Community Data Program Steering Committee, using a decision-making process consistent with the Community Data Program [Governance Structures and Operating Procedures](#). Data acquisition constraints

Time to produce the data and make it available

Note that making data available takes time. While certain products will be available within weeks of purchase, custom orders may take up to 12 months for delivery.

Production capacity

Acquisition of the data listed in Schedule B is subject to the production capacity of the data providers. Notably, Statistics Canada has a limited number of analysts who can fulfil custom orders. Production of tables at custom geographies is similarly constrained, particularly during the geocoding phase. Statistics Canada's production capacity has also been affected by measures taken to limit the COVID-19 pandemic.

Budget, priority ranking

The cost of all data products listed in Schedule B exceeds the acquisition budget for the 2020-2021 program year. Products will be acquired according to their priority (indicated as *high* or *low* in the table below) and subject to what Statistics Canada and other providers can produce.
